BRIDGE REHABILITATION PROJECT**

Navajo Tribal Utility Authority (NTUA) is hereby requesting bids for the construction of the Moenkopi Wash Drainage Improvements project. Sealed bids shall be provided to the NTUA Purchasing Department, at North Navajo Route 12, Fort Defiance, AZ 86504 no later than 4:00 pm local time on June 24, 2025, after which the public opening and reading of bids received will begin. No late, facsimiled, or electronic mailed bids will be accepted. Nation Procurement act (12 N.N.C 301 et seq.); Navajo Business Opportunity Act (5 N.N.C. 201 et seq.) and other applicable requirements. Suppliers, brokers, agents, subsidiaries, successors, and assigns shall be fully subject to the requirements and provisions of the Navajo Nation Business Opportunity Act.

Proposers must submit evidence of their Preference Priority Certification if applicable.

**GENERAL DESCRIPTION AND LOCATION OF PROJECT:**

The project is located in Tuba City, AZ and is intended to stabilize the banks of the Moenkopi Wash and to replace a sewer pipe bridge at the Tuba City Wastewater Treatment Plant. Placement of 2,260 CY of Rip Rap, shaping and grading, removal and replacement of a 144 ft steel bridge, the replacement of 485 LF of 18-inch sanitary sewer line, and other associated items will be required to complete the project.
