**Drilling and Installation of Kayenta Well No. 9 & Tsaile Well No. 9**

ADVERTISEMENT FOR BIDS

Sealed Bids for the **Drilling and Installation of Kayenta Well No. 9 & Tsaile Well No. 9** will be received by Navajo Tribal Utility Authority, **Attn: Andrea Hale, at the NTUA Headquarters, North Navajo Route 12, Fort Defiance, AZ 86504**, until **5 pm** local time on **November 19, 2024**. The Bids received will be **publicly** opened and read on **November 20, 2024, at 10 am**. No late, facsimiled, or electronic mailed bids will be accepted. Each bid response shall be submitted in accordance with EJCDC C-200 Instructions to Bidders. The project consists of:

1. Kayenta Well No. 9: Installation of 20" diameter, 50' long surface casing; Drilling of a minimum 6-3/4" diameter pilot boring to a depth of 1,120 feet below ground surface (bgs); Conducting geophysical logging; Pilot hole reaming to final diameter as specified; Constructing 10" diameter well as specified; Performing well development, water quality testing, and pump testing.
2. Tsaile Well No. 9: Installation of 20" diameter, 50' long surface casing; Drilling of a minimum 6-3/4" diameter pilot boring to a depth of 700 feet below ground surface (bgs); Conducting geophysical logging; Pilot hole reaming to final diameter as specified; Constructing 10" diameter well as specified; Performing well development, water quality testing, and pump testing.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis, as indicated in the Bid Form.

Prospective Bidders may examine the Bidding Documents at the Issuing Office on Mondays through Fridays between the hours of **8 am to 5 pm** and may obtain copies of the Bidding Documents from the Issuing Office as described below.

Bidding Documents may be viewed and ordered online by registering with the Issuing Office at [www.academyplans.com](http://www.academyplans.com). Following registration, complete sets of Bidding Documents may be downloaded from the Issuing Office's website as portable document format (PDF) files. The cost of printed Bidding Documents from the Issuing Office will depend on the number and size of the Drawings and Project Manual, applicable taxes, and shipping method selected by the prospective Bidder. Cost of Bidding Documents and shipping is non-refundable. Upon Issuing Office's receipt of payment, printed Bidding Documents will be sent via the prospective Bidder's delivery method of choice; the shipping charge will depend on the shipping method chosen. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of the Bidding Documents will not be available from the Issuing Office.

Preference will be applied to qualified Navajo and Indian-owned businesses in accordance with the Navajo Nation preference laws as specified in the Navajo Nation Business Opportunity Act (5 NNC § 201 et. seq.), the Navajo Nation Procurement Act, (12 NNC § 301 et seq.), and the Navajo Business and Procurement Act (12 NNC § 1501 et seq.) and other applicable statutory and regulatory requirements.

A pre-bid conference will be held at **9 am MST** local time on **November 4, 2024**, at the NTUA Headquarters in Fort Defiance, AZ, and virtually through Microsoft Teams. Site visits will be completed following the pre-bid conference. Interested bidders should sign up with the issuing office and a Microsoft Teams meeting invite will be sent out to the registered emails. Attendance at the pre-bid conference is highly encouraged but is not mandatory. Questions regarding bid documents are due to the Engineer (listed below) on **November 11, 2024, at 5 pm MST**. Bid security shall be furnished in accordance with the Instructions to Bidders.
